#### Work in solidarity to combat terrorism, climate change -Speaker Bagbin charges African legislators

peaker of Ghana's Parliament, Rt. Hon. Alban Sumana Kingsford Bagbin, has urged African legislators to unite under the principles of Pan-Africanism to address pressing issues such as terrorism, conflicts, and climate change.

Speaking at the First Ordinary Session of Côte d'Ivoire's National Assembly on Monday, Speaker Bagbin emphasized the urgent need for collective action to tackle challenges that undermine stability and development across West Africa. He called on lawmakers to leverage parliamentary diplomacy as a tool to foster peace and drive sustainable growth.

The event, hosted by H.E. Adama Bictogo, President of Côte d'Ivoire's National Assembly, brought together parliamentary leaders from Senegal, Benin, Togo, Nigeria, and the ECOWAS Parliament. Speaker Bagbin was accompanied by his spouse, Madam

Linda Ofosuah Oboh, as well as Members of Parliament Hon. Habib Iddrisu, Hon. Dorcas Toffey, Hon. Dr. Sebastian Sandaare, and other parliamentary staff.

Highlighting the critical role of legislators in solving regional problems, Speaker Bagbin called solidarity among African lawmakers. "African legislators must stand united to combat terrorism, resolve conflicts, and confront climate change," he stated, stressing that collaboration is key to overcoming these challenges.

voice, Adding his President of Nigeria's Senate, Godswill Akpabio, addressed the assembly, emphasizing the importance of partnership between African nations. He noted that countries like Nigeria and Côte d'Ivoire share a collective responsibility for the continent's progress.

"The future of West Africa rests upon us. Therefore, let us not be complacent. The challenges before

us are vast - youth unemployment, human trafficking, and security threats. Yet, so too are the opportunities," Akpabio remarked. He further called for unity national across boundaries, urging lawmakers to lead efforts toward deeper integration. "The colonialists may have divided Africa into geopolitical chunks, but we must unite and repair the torn fabrics of our heritage. Let us envision a region where borders

serve as bridges of unity, not walls of division, where trade flourishes, cultures blend, and progress becomes a right for every citizen," Akpabio concluded.

The session underscored the importance of parliamentary collaboration in fostering unity and advancing a shared vision of prosperity and stability for Africa. Leaders at the gathering reaffirmed their commitment to addressing the continent's challenges through coordinated legislative action.

# 1st-year tertiary students who have already paid their admission fees will get a refund – Haruna Iddrisu

inister-designate Education, Haruna Iddrisu has indicated that firstyear students in public tertiary institutions who have already funded their admission fees will be reimbursed by the government.

In an interaction with Parliament's **Appointments** Committee Monday, the minister-designate who doubles as the Tamale South Member of Parliament (MP) noted that the government will collaborate with the Finance Ministry to ensure that the refund process is seamless and that the necessary funds are allocated to support the initiative.

"On the authority of President Mahama and with the endorsement of the Finance Minister-designate, Hon. Ato Forson, this funding will be included in the Reset Budget. It will ensure that fees for general academic courses are refunded.

According to him, this compliments president John Mahama's plans to make higher education more accessible and affordable for all

Ghanaians.

"President Mahama sees this as a pilot program to evaluate its viability. If successful, it could be expanded in the future. That said, those willing and able to pay their fees can still do so," he explained.

During the launch of the Youth Manifesto ahead of the 2024 elections, President Mahama vowed to introduce a tuition-free scheme for first-year students in public

minister-designate the Also, disclosed that the government has set aside GH¢345 million to fund this initiative, covering general academic programs.

However, MP for Builsa South, Dr. Clement Apaak, has indicated that the National Democratic Congress' (NDC) government's commitment to providing free first-year university tuition will not be mandatory for all

Speaking to the media, he explained that the initiative is designed such that parents and guardians who wish to cater for the fees of their

wards will not be prevented from doing so.

"That is an opinion. In any case, it is not going to be by compulsion. If there are persons who feel that they don't need it and would not want to be beneficiaries of this arrangement, they are free to opt out. But as far as this is a manifesto promise made by John Mahama and the NDC to the people of Ghana, based on which we are now in government, we intend to carry it through," he added.

#### Parliament approves 6 appointees of Mahama as ministers

arliament has given its approval to six ministerial nominees appointed President John Dramani Mahama, paving the way for their official swearing-in as substantive ministers. The approvals followed rigorous vetting by the Appointments Committee subsequent debates in the House.

The latest set of appointees, including Kwame Governs Agbodza as Minister for Roads and Highways, Eric Opoku as Minister for Food and Agriculture, and Haruna Iddrisu as Minister for Education, were endorsed on Tuesday, January 21, during a sitting chaired by Second Deputy Speaker Andrew Asiamah Amoako.

Earlier on January 13, Parliament had also approved the nominations of Dr. Cassiel Ato Forson as Minister of Finance, John Abdulai Jinapor as Minister of Energy, and Dr. Dominic Akuritinga Ayine as Minister of Justice and Attorney General. approvals These underscore President Mahama's commitment to assembling a team to address key national priorities.

nominees received The endorsements from legislators

across the aisle, who commended their qualifications and commitment to national service. Speaking on the floor, Minority Leader Alexander Afenyo-Markin expressed optimism about the appointees' ability to deliver on their mandates.

"They should not disappoint us. We wish them all the best," other members of Parliament echoed.

With the approval of these six appointees, President Mahama's administration takes another step toward fulfilling its governance agenda and addressing national challenges.

During his vetting, Haruna Iddrisu outlined plans to address Ghana's educational infrastructure deficit by prioritizing the uncapping of the Ghana Education Trust Fund (GETFund) to improve the sector's development.

Kwame Governs Agbodza emphasized reintroducing road tolls through advanced technological platforms to enhance revenue collection and reduce traffic congestion. Eric Opoku proposed establishing agricultural farms in Senior High Schools nationwide to leverage the country's land resources and support agricultural sector.

Dr. Cassiel Ato Forson committed to improving Ghana's tax compliance to increase tax revenue without raising taxes, targeting a rise to 16% of GDP. John Abdulai Jinapor outlined a strategy to involve the

private sector in the operations of the Electricity Company of Ghana (ECG) to boost efficiency and ensure reliable power distribution. Dr. Dominic Akuritinga Ayine, meanwhile, revealed plans to reintroduce a revamped public tribunal system to enhance access to justice and protect citizens' rights.

#### NPP govt left GH¢100bn in commitments for road construction; GH¢20bn unpaid certificates - Agbodza

oads and Highways Ministerdesignate, Governs Kwame Agbodza, has raised concerns about the substantial financial obligations tied to road infrastructure projects, continue to place a significant strain on Ghana's economy.

Speaking during his vetting by Parliament's Appointments Committee on Monday, January 20, Mr. Agbodza disclosed that the previous government left behind commitments amounting to at least GH¢113 billion. This figure includes GH¢20 billion in unpaid certificates owed to contractors and GH¢15 billion tied to the Road Fund.

"The NPP government is leaving a minimum of GH¢113 billion in commitments. What is particularly concerning is that certificates unpaid as of today from the Government of Ghana amount to about GH¢20 billion. Additionally, the Road Fund owes approximately GH¢15 billion," he revealed.

Mr. Agbodza further highlighted that the financial strain is exacerbated by accumulated interest payments. "The interest on this GH¢113 billion is about GH¢665 million, due to the nature of contracts signed under the previous administration," he added.

These unpaid obligations have farreaching consequences. Contractors face significant delays in receiving payments, stifling local businesses and disrupting economic activities. Moreover, the GH¢665 million in interest payments diverts critical funds that could be allocated to other essential sectors such as education, healthcare, and social welfare.

The minister-designate emphasized the urgent need for measures to address these financial burdens, which account for a significant portion of Ghana's national debt. "These commitments place immense pressure on public finances, and we must explore innovative solutions to ensure that infrastructure development does

not come at such a heavy cost," he stated.

The revelations have sparked discussions on the sustainability of road infrastructure financing and the need for prudent contract management to prevent similar challenges in the future.

Larry Gbevlo-Lartey has been named Special Envoy to the Alliance of Sahelian States and will also serve as a Presidential Staffer. Professor Kwaku Danso-Boafo assumes the role of Cabinet Secretary, a position central to coordinating cabinet activities.

# DRIP lacks management contract due to procurement of machines by the Presidency - Ahmed Ibrahim

he Minister-designate Government, Local Chieftaincy, and Religious Affairs, Ahmed Ibrahim, has raised concerns over the management and implementation of the Direct Roads Improvement Programme (DRIP), citing the absence of a management contract.

This situation arose because the procurement of machines for the programme was handled directly by the Office of the President during the Akufo-Addo administration.

Speaking during his vetting before Parliament's Appointments Committee on Tuesday, Mr. Ibrahim disclosed that the Ministry of Local Decentralisation, Government, and Rural Development, which was tasked with spearheading the initiative, was sidelined during the procurement process.

"Workers in the Ministry of Local Government watching me would testify that they have no records

of any agreement related to the DRIP project," he stated. "There is no programme or inventory of the DRIP machines. This is a challenge because it was procured through the Office of the President, which has created problems."

The DRIP initiative, launched by former President Nana Akufo-Addo at Independence Square on July 31, 2024, was intended to address deteriorating road conditions across all 275 constituencies. This initiative was in response to a report from the National Security Ministry identifying poor road infrastructure as a potential threat to national stability.

Despite its ambitious goals, Mr. Ibrahim pointed out several shortcomings in the programme's implementation framework. "There is no management contract, no provisions for spare parts, and no committees established to oversee the machines," he explained, adding that these deficiencies

have hindered the programme's effectiveness.

However, the minister-designate expressed his resolve to address these challenges and ensure the programme's success. "We are committed to ensuring that the DRIP programme materialises and delivers on its promise of enhanced road infrastructure in all districts," he affirmed.

Mr. Ibrahim also underscored the need for accountability and efficient utilisation of resources

achieve the programme's objectives. "It is crucial that the equipment and resources allocated to this programme are used for their intended purpose. We will closely monitor its execution to ensure that roads are built to the highest standards," he assured.

As he prepares to take on his ministerial role, Ahmed Ibrahim faces the daunting task of rectifying the structural issues in the DRIP initiative to fulfil its potential and improve Ghana's road infrastructure.

# Schools to reopen in Obuasi once peace, safety are guaranteed - Ashanti Regional Minister-designate

he Ashanti Regional Minister-designate, Frank Amoakohene, has expressed confidence that life in the Obuasi community will soon return to normal, with work and schools resuming, provided peace and safety are ensured.

Speaking to the media, Mr. Amoakohene revealed that the decision to resume activities was reached after extensive engagements with the affected communities and key stakeholders. "Once we are certain that the stakeholders—especially communities—are at peace and have confidence in the processes initiated by the President, we believe work can resume. Schools can reopen because they cannot remain closed indefinitely while investigations are ongoing," he stated.

Mr. Amoakohene expressed optimism that ongoing discussions stakeholders, including AngloGold Ashanti (AGA), would facilitate a smooth return to regular activities.

"After engaging with them, we realized that they were feeling more

at ease. With continuous dialogue, we should be able to get the company back to work and everyone back to their respective duties, pending the final determination of the matter," he said.

He clarified that the incident in question occurred in a part of the mine that is not actively used for mining operations, which allows work in other areas to proceed without interference.

"AngloGold Ashanti has a northern camp and a southern area where active mining processes take place. The incident occurred within the northern side, which is not an active mining site. As far as the Attorney General is concerned, they can commence work without affecting or tampering with the evidence," he explained.

Addressing concerns about injured security personnel, Mr. Amoakohene shared that he had personally visited one of the injured soldiers to check on his recovery and conveyed the President's goodwill message.

"We visited him and delivered the President's compliments. Our men in uniform, who serve the country diligently, are a major concern to the President. Adequate provisions have been made to cover his medical expenses and ensure his full recovery," he affirmed.

The minister-designate assured the public of the government's commitment to transparency and inclusivity in addressing the issue.

"It is our responsibility to ensure that all parties, including those directly and indirectly affected, feel reassured and confident in the measures being put in place. We are committed to seeing this process through to its logical conclusion," he stated.

Mr. Amoakohene concluded by calling for calm and cooperation as investigations continue. He emphasized that the authorities working diligently restore stability and ensure the community's return to normalcy.

# NPP suspends 58 members in Tatale for failing to support parliamentary candidate

**T**he New Patriotic Party (NPP) in the Tatale-Sanguli constituency of the Northern Region has suspended 58 members for allegedly refusing to support the party's parliamentary candidate in the recent elections.

A letter addressed to the national and regional executives, signed by the constituency chairman, cited breaches of the party's constitution as the basis for the decision.

Article (3) clause (9) (1) states, "A Member of the Party who stands as an independent Candidate against the officially elected member of the party or joining or declaring his or her support for another political party, or for an independent candidate when the party has sponsored a candidate in a general or by election automatically forfeits his or her membership of the party.

"According to article (3) Clause (7) (1)," A Member may be suspended from membership of the party, or holding any office in the party,

pending an enquiry into his or her conduct by a Disciplinary Committee."

According to the chairman, the affected members actively worked against the party's candidate during the campaign, undermining the collective effort to secure victory.

One of the suspended members, Prosper, Napare former constituency communication officer, has rejected the allegations and demanded evidence to support the claims. He also criticized the manner in which the decision was communicated.

#### BoG adjusts gold coin rates following global gold price rise

¶ hana's Central Bank has revealed a modest increase in the price of its gold coins, in line with the recent surge in global gold prices.

The gold coins, available in 0.25oz, 0.50oz, and 1oz denominations, are now listed at GHS 11,248, GHS 21,623, and GHS 42,435, respectively.

As of November 2024, the coins were priced as follows: the 1.00 oz coin at GH¢45,020.48, the 0.50 oz at GH¢22,409.74, and the 0.25 oz at GH¢11,188.12.

This price adjustment coincides with gold prices on the London Bullion Market Association (LBMA) reaching \$2,715 per ounce on January 20, 2025, driven by strong demand amid ongoing global economic volatility.

The Bank of Ghana's (BoG) Ghana Gold Coin (GGC) initiative, launched as part of its national gold policy, offers a viable investment alternative for Ghanaians, addressing both personal financial goals and larger economic concerns. The initiative is designed to absorb surplus liquidity in the financial system, thereby fortifying the

Ghanaian Cedi and promoting overall economic stability.

The central bank urges investors to closely monitor fluctuations in the value of gold and exchange rates, as these factors can significantly impact the worth of the coins.

Through the GGC initiative, individuals can diversify their investment portfolios, participate in the international gold market, and contribute to both their financial security and the country's economic resilience.

#### Bank stocks to perform better in 2025 due to strong earnings, dividend upturn - Databank research

anks stocks are expected to do well according to the latest projections from Databank Research in its Ghana Market Outlook 2025 report, released in January.

This is as a result of increased profits hence investors have begun earning higher dividends.

These predictions come on the back of renewed interest by investors following the introduction of Domestic Debt Exchange Programme (DDEP) government in December 2022 which caused a decrease in investor confidence and stock prices.

Banks holding government bonds suffered substantial impairment losses due to the exchange of old bonds for new ones with lower coupon rates. This led to a decrease in the value of their bond holdings and negatively affected their balance sheets.

However, investors began showing renewed interest in banking stocks around mid-2024 due to improved

economic conditions and regulatory reforms that bolstered investor confidence. The Financial Stock Index saw 15% gains by the end of Q3 2024.

Consequently, banks stocks are anticipated to continue to perform well " ... supported by a

strong earnings outlook and the return of dividend payouts", parts of the research said.

It continued that "these factors are likely to attract income-focused investors, further boosting sector's appeal".

Also, the research suggests that local banks are set to see a significant boost in profitability. With the introduction of a new cash reserve ratio requirement by the regulator. banks are expected to experience growth in their loan portfolios and a marked improvement in asset quality

"We expect banks' profitability to benefit significantly from loan book expansion and improved

asset quality following regulator's new cash reserve ratio requirement" it added.

Meanwhile, the Domestic Debt Exchange Program (DDEP), announced on December 5, 2022, involved swapping old domestic bonds valued at GHC 137.3 billion (US\$14.3 billion) for new bonds with longer repayment terms and lower interest rates.

This exchange caused significant losses for banks, with local banks losing GHC 19.9 billion and foreignowned banks losing GHC 17.8

billion. Some local banks became technically insolvent and needed to raise additional capital to recover. The program initially damaged investor confidence, as it challenged the idea that government bonds were completely safe investments. The losses suffered by bondholders and the lower interest rates on the new bonds led investors to become more cautious.

#### Reconsider intent to withdraw from organisation -WHO to US

he World Health Organization (WHO) has appealed to the United States to reconsider its decision to withdraw from the global health body.

This comes after an executive order was issued under the directive of President Donald Trump, signaling the United States' intent to sever ties with the organization.

In the order, Trump cited the WHO's alleged mishandling of the COVID-19 pandemic, its resistance to reform, and its dependency on politically influenced decisionmaking by certain member states.

Additionally, the disproportionate financial burden placed on the US was highlighted as a critical issue. "China, with a population of 1.4 billion, contributes nearly 90 percent less than the United States," the order emphasized.

directive revoked earlier actions that reversed the 2020

withdrawal notice and called for immediate measures, including pausing funding, recalling personnel, and ceasing negotiations on international agreements related to the WHO.

The WHO, however, expressed regret over the decision, emphasizing its vital role in protecting global health. "WHO plays a crucial role in protecting the health and security of the world's people, including Americans, by addressing the root causes of disease, building stronger health systems, and detecting, responding preventing, and emergencies," to health organization noted in a statement. The WHO underscored the historic partnership between the United States and the organization, which dates back to 1948, pointing out significant achievements such as eradicating smallpox and nearly eliminating polio.

"Together, we have saved countless lives and protected Americans and all people from health threats," the statement added.

The global health body also highlighted its ongoing reforms to improve accountability, costeffectiveness, and impact, while expressing hope for a constructive dialogue to restore the partnership. "We hope the United States will reconsider and we look forward to engaging in constructive dialogue maintain the partnership

between the USA and WHO, for the benefit of the health and well-being of millions of people around the globe."

As the withdrawal process unfolds, the WHO remains committed to its mission of safeguarding global health and fostering international cooperation in addressing pressing health challenges.

### Gabon approves new electoral law seen as win for junta leader

abon's transitional parliament on Monday approved a new electoral code seen by opponents as favourable to junta leader Brice Oligui Nguema.

The bill which was passed after days of deliberations allows members of the security forces and magistrates to contest elections as candidates.

Nguema has promised to return power to civilians but speculation that he desires to run as a presidential candidate is rife.

For its part, the opposition is demanding a formal ban on any military member of the transition committee standing as a presidential candidate.

But members of the junta have recently embarked on a propaganda drive seen by observers as a plan to soften the ground for a potential Nguema candidacy.

The bill also introduces two parliament seats reserved for diaspora Gabonese.

It allows dual nationals to stand as candidates in all elections except

the presidential vote without having to renounce their other nationality. The text also moves

responsibility to organize elections to the interior ministry from that of local government.
